The Employee Foundation aims to make a positive impact in the communities in which we work and live by sharing our expertise and funding across three impact pillars: financial literacy and inclusion, technology training and education, and vibrant communities. Since its inception in late 2019, the Affirm Cares Employee Foundation has raised and awarded grants of over half a million dollars to local community non-profits. In 2021, our employee-led foundation distributed over one-hundred thousand dollars to nonprofits focused on housing, racial equity, the environment, and education.


FINANCIAL LITERACY & INCLUSION
